

The following T's and C's apply to the Spring on us promotion:

1. The advertised promotion is only valid in Vumatel Fibre ready areas; this promotion is not valid for pre-orders.
2. The promotion will start 2 September 2019 and is valid for all orders received before midnight on the 30 September 2019.
3. All Participants are required to stay a minimum term of 12 months, in order to qualify for their discount.
4. If you cancel with in the 12-month period or your account goes into arrears, you will be liable for the full month fee, the connection fee (R1008) and the installation fee if applicable.
5. Customers are offered a 66% discount for the first three months, if they opt to pay the once off installation fee of R1,725.
6. Customers are offered a 33% discount for the first three months, if the installation and connection fee is covered by IPComms.
7. The discount only applies to the monthly line rental cost and not any add-ons or services, selected by the customer.
8. After the three months, customers are liable to pay the full monthly price of their selected Vumatel package until the 12-month minimum period is complete.
